- Mid-Year Reviews

Andrew Lewis thanked the SICAP Sub Group for their assistance with the review of lot 18.4 SECAD Partnership CLG. He noted that the subgroup met Toni McCaul of SECAD Partnership CLG to assess the Local Development Company's progress.

Andrew Lewis said that both KPI1 and KPI2 had been significantly achieved by lot 18.4. He noted that KPI 1 is 59% achieved and KPI 2 is 99% achieved which is excellent progress. He said that the budgets are on track to be spent this year and recommended the review for approval by the LCDC.
