- "Calling for Beechcourt, Carrigaline to be included in the next resurfacing program. St. Philomena's & Dan Desmond Terrace was resurfaced in previous years, I'm asking for a continuation of this into Beechcourt to complete the estate."
- 2. "Residents have raised concerns about flooding on the road at Ballyguinnane, Carrigaline (off Forest Road). I'm requesting drainage works to be carried out as soon as possible in this location."
