#### Welcome and Introduction.

The Chair welcomed to the Committee, Mr. Michael Lynch, new Divisional Manger for South Cork. Also, Ita Kirwan new Staff Officer to the Community & Development Team. It was noted that a quorum was in place and the meeting commenced.

# 1. Confirmation of Minutes of the Previous LCDC Meeting of 26th October 2023.

The Minutes were adopted on the proposal of Tom Howard and seconded by Cllr Cathal Rasmussen.

## 2. Community Support Fund 2022/2023 Reallocations.

The scheme was rolled out in April 2023 with a fund of €362,678 for Capital and Operational Costs. The closing date was 30<sup>th</sup> September 2023 initially, this was extended by a month to 31<sup>st</sup> October 2023. There were some underspends following the closing date. These were reallocated based on receipts received and with a focus on Community Groups. Those with lesser amounts, this is the maximum that could be allocated.

Liam McCarthy asked if there is any indication of funding for next year and Kay Keegan confirmed that there has been no information this regard yet.

#### 3. Update on SICAP - Contracts for new programme

The current SICAP funding is ending in December 2023. Procurement for next year started over the summer. The Evaluation Team was made up of Declan Daly, Chair, Marian Salter, Derek O'Gorman and Angela Murphy. The team met on several occasions, in person and online. There were 7 Lots for Cork County with 1 Lot from South Cork so no competing bids. A negotiation element was introduced to the process this year. As the final score was over 70%, as per the criteria, no negotiation meeting was required.

- National Briefing session had been held online at the end of August 2023.
- Local Briefing sessions for the Evaluation team had been held in County Hall on 13<sup>th</sup>
   September.
- Tenders were opened and downloaded from eTenders on 8<sup>th</sup> September.
- Tender documentation received by Evaluation Team members on 13<sup>th</sup> September.
- There were 7 Lots for Cork County, 1 of these Lots for South Cork, one tender received in respect of each lot. Lot number 18-4 for the South & East Cork
- Meetings of the Evaluation Team were held on 13<sup>th</sup>, 25<sup>th</sup> and 28<sup>th</sup> September in person with other meetings held online.
- National Evaluation Template has been set by Pobal with a clear marking system of 7 criteria and 16 sub criteria.
- A joint evaluation was undertaken by all members of the Evaluation Team, and all decisions were reached by consensus.
- Ongoing clarification was given to the Evaluation Team by the Chief Officer and her staff.
- One tender was received in respect of each lot and each tender met all requirements.
- Lot 18.4 SECAD –South & East Cork. the marking criteria and the conversion which gave this Tenderer a total mark of 815 out of 1090.
- On 18<sup>th</sup> October 2023, the Chair of the Evaluation Team, Declan Daly, met with the SICAP
  Sub Committee comprising of Leighann Kennedy Dept Social Welfare and John Fitzgibbon
  CETB with the Chair of the South Cork LCDC also being briefed in advance. The SubCommittee agreed with the recommendation of the Evaluation Team with SECAD being
  successful. Award Letters were issued last week and awaiting contracts.

The Chair acknowledged the work of the Evaluation Team and the SICAP Sub Committee, and congratulated SECAD.

Ryan Howard thanked LCDC for their support throughout the process and acknowledged how good it is to have continuity for the area. He did however wish to raise a concern with regards to the budget. The starting point for budgets was basically the same from the previous year, but for South Cork, this has been reduced by 10%. He acknowledged that this was because of reduction in population but stressed the importance of supporting people on the ground, particularly in outlying areas. Ryan wanted to raise the issue prior to signing the contract and is seeking support from South Cork LCDC to have the budget reinstated.

The Chair acknowledged the importance of reinstating the 10% and extended support from the South Cork LCDC members in the form of a letter to each of Cork's three representatives, Minister Michael Martin, Minister Michael McGrath and Minister Simon Coveney including Minister Heather Humphreys DRCD.



Kay Keegan acknowledged that budgets were based on size, population area & areas of deprivation and that the difference for Cork County was due to the boundary changes

The Chair put it to the committee for a letter and contact with the three Cork Ministers & Minister Humphreys. Proposed by Ryan Howard and seconded by Cllr Michael Hegarty.
