Uimh. 477/2011), leasaithe.

  - c. Aon chomhairliúchán faoi alt 14.

- iv. Na forálacha a roghnaíodh le monatóireacht a dhéanamh, de réir alt 17, ar éifeachtaí suntasacha timpeallachta an phlean nó an chláir, nó leasú ar phlean nó ar chlár.

No. 477/2011), as amended.

  - iv. the measures decided upon to monitor, in accordance with article 17, the significant environmental effects of implementation of the plan or programme, or modification to a plan or programme.
