#### REPAIR AND REHABILITATION OF ARDCAHAN BRIDGE (R587), ARDCAHAN, COUNTY CORK.

Pursuant to Section 177AE of the Planning and Development Act 2000 (as amended) and the requirements of the planning and Development Regulations 2001 (as amended), notice is hereby given that Cork County Council proposes to make an application for approval to An Bord Plenala for the following development:

**Rehabilitation works of an existing structure at Ardcahan Bridge to allow corrosion repairs and minor parapet repairs within the bridge structure, deck works to repair the road surfacing and temporary site compound at Ardcahan Bridge, Ardcahan, Co. Cork.**

A Natura Impact Statement has been prepared in respect of the proposed development.

The Board may, in relation to an application for approved under section 177AE of the Planning and Development Act 2000, as amended, give approval to the application for development with or without conditions or may refuse the application for development.

The Natura Impact Assessment, together with Plans and Particulars of the proposed development will be available for inspection free of charge or may be purchased on payment of a small fee (which fee shall not exceed the reasonable cost of making such a copy) during normal office hours 09.30am-5.00pm Monday to Friday (excluding bank holidays), during the period from 19th April 2024 to the 30th May 2024 inclusive at the following locations;
