M28 Cork to Ringaskiddy:

A number of project elements are being progressed. These include the following:

- •Site clearance & fencing substantially progressed
- •Liaison with all Utility Providers ongoing with ESB, IW, Enet. Extensive utility diversions are ongoing across the site, including diversions of the Harbour & City watermain, ESB lines and EIR and Enet services.
- •The main Archaeology contract was awarded in 2021 and is progressing well.
- •Ongoing Stakeholder engagement with affected landowners and land acquisition ongoing.
- •Active Travel Plan options are being progressed.
- •Tender competition to appoint Technical Advisors for detailed design and construction supervision completed in 2023.
- •Tender process for main construction contract(s) to be progressed in 2024.
- •Public Spending Code Approvals required before contractor appointment
- •Scheme included in NDP 2026 2030

•2024 funding allocation falls short of the level of funding required to maintain momentum on this project.

N22 The Baile Bhuirne to Macroom Scheme

The main Design and Build Contract was awarded to a joint venture of Jons Civil Engineering Ltd and John Cradock Ltd., on the 17th of October 2019.

- Cork County Council opened a section of the scheme on the 9th December 2022. This sectional opening, described as the Macroom Interim Bypass extends from the new roundabout at Coolcour to Carrigaphooca.
- A further sectional opening between Carrigaphooca and Toonlane was achieved on the 11th August 2023.
- The balance of the scheme was officially opened to traffic on 6th November 2023.

N8/N25 Dunkettle Interchange:

- •In terms of link openings, a number of the new links opened simultaneously, to their permanent alignment in early July 2023.
- •Link D: Northbound (N40 to M8) was opened to traffic in September 2023.
- •The balance of the links were completed in advance of the official opening of the scheme.
- •The project reached substantial completion and was officially opened on 12th February 2024.

N72/N73 Mallow Relief Road:

- Options Selection Report completed and approved in 2022.
- Site investigations along the route corridor were progressed during the summer months of 2022.
- Activity on this project during 2023 was largely suspended.
- 2024 funding allocation falls short of the level of funding required to re-establish and maintain momentum on this project.

Labour shortages

- The shortage of skilled labour for key trades continues.
- Number of undergraduates studying for key professions such as engineering, architecture, & QS, still recovering after last recession.
- Shortage of suitable candidates for general operative roles.

Severe Weather

• The impacts of severe weather events across the county in 2023 most notably Storm Babet will be felt for some time.

Conclusions for R&L Roads:

- Despite the challenges of 2023, CCC spent all the 2023 allocation
- CCC received an allocation excluding severe weather allocation of €70,199,560 in 2024, a minor decrease of 1.6% on the 2023 allocation
- The delivery of a programme of repair of the storm damaged roads and structures will be a significant challenge in 2024 .
- Stubbornly high inflation, particularly in energy costs, will have a significant impact on the quantum of work that will be delivered in 2024.
- The 2024 allocation remaining in line with the 2023 allocation as well as the significant allocation for severe weather damage confirms Government confidence in Cork County Council to deliver essential road maintenance and improvement works across an extensive 11,740km R&L roads network. However, more funding is needed to maintain and improve the network.

A dedicated implementation technical team (SBIU) was established to progress Tranche 1 and Tranche 2 of the above programme.

Progress to date is as follows:

- SBIU mobilised in January 2024,
- Initial storm damage surveys completed, detailed surveys ongoing,
- Tranche 1 and Tranche 2 of the programme of works submitted to DOT,
- Tendering and procurement processes ongoing,
- Detailed design ongoing including site assessments
- Works are currently being completed in all 9 Municipal Districts,
- There are currently 7 Contractors progressing work packages throughout the county in addition to works being completed in-house by Road Ops.

During this discussion, the Members made the following points:

- Said they are disappointed with the allocated funding for N25 and that it has been shelved by the Minister
- Said there is not enough funding for the works that need to be completed
- Welcomed the funding allocated for the works in Charleville and asked if there is a timeline for these works to be completed
- Said it is disappointing that drainage works are down by 30% from last year
- Asked what funding is available for works on the old N22
- Asked if it is possible for the TII to bring forward works to be completed on the town centre in Fermoy
- Said it is disheartening that options for the Bandon Bypass are still being considered and further progression on the project has not been made
- Members said some of the funding proposed for greenways should be postponed and put towards the road network
- Said local and regional roads are essentially the nuts and bolts of how this County operates
- Said the local and regional road network keep the County ticking over
- Said this issue has been going on for 63 years since the West Cork railway closed
- Said there is no point in having greenways in place until the road network improves
- Said it should not be seen as one or the other between greenways and active travel
- Said this county cannot deal with the paltry amount of funding that has been allocated
- Asked if all the extra money for Storm Babet / greenways comes from the roads allocations?
- Members said there is now a shortfall of €273 million in funding in comparison to what Cork County Council were allocated in 2008

- Shows that economic cycles have a detrimental effect on funding allocations for the road network
- Said the roads have been neglected since 2008 when the grant allocations decreased
- Asked what is the difference in cost between improving a kilometre of road in 2008 versus the current cost
- Said there are some roads in West Cork that are not fit for travel
- Said it is worrying that Cork County Council submitted a funding request of €55 million for Storm Babet repair works and the amount allocated is €26 million
- Members asked what will Cork County Council be able to do with the assigned funding for Mallow Relief Road?
- Said the amount allocated will only be able to be complete works for the first half of the year
- Asked if Cork County Council have liaised with the NTA for more funding?
- Asked how much funding Cork County Council applied for in relation to the Mallow Relief Road?
- Asked how much is needed to bring the Mallow Relief Road to the planning stage?
- Members said priority needs to be given to carrying out drainage works
- Said Cork County Council should look at putting extra drainage crews on the roads to deal with the extra surface water
- Said Kerry are getting €10,000 per km while Cork are getting €6,000 per km
- Said parity is needed between the Cork and Kerry road network
- Members said public opinion is tested because of the condition of some of the roads
- Said they are concerned about the capacity of the road in Cobh to take extra residential work
- Said safety measures need to be put in place on the N27 at Castlemartyr National School and in Mogeely to deal with the increased traffic since the greenway opened
- Asked how the allocation for Cork County compares to other counties in Ireland
- Asked when the climate action and resilience works for Main Street in Carrigaline is due to get funding
- Said active travel is not frivolous and must not be sidelined
- Said it is positive to see progress on active travel routes
- Members asked about the delivery of new carparks around Cork County
- Members said the lack of funding allocated to Cork County will have to be made clear during the upcoming delegation with Minister Jack Chambers

Members agreed to write to the Department of Housing, Local Government & Heritage to request that LIS / CIS schemes include drainage works.

Niall Healy, Director of Services, responded to the Members as follows:

- There is a large amount of work currently on going in Cork County
- Said the Executive are as frustrated as the Elected Members as anyone else with the funding
- There is a legacy of underinvestment with Cork roads
- The national roads are often the first impression that visitors get of the road network
- Said Cork County Council will spend every cent that is allocated and there is evidence of that with the Storm Babet funding
- Said Cork County Council cannot deliver on the objectives set out in the National Policy Guidelines
- The funding for greenways and active travel investment is welcomed
- The relief road for Charleville is at a very early stage
- There is a lot of work to be done on the Eastern Relief Road in terms of business cases & statutory documents
- There is funding available for the former N22 as funding is made available every year for former national routes

- Said the target for Fermoy town is for construction to begin in Q3 and to finish before Christmas
- Said progress can only be made on the Bandon Bypass project as much as funding allows
- The allocated funding for Storm Babet works is €13 million, not €26 million
- Said there is funding for the N25 from Midelton to Youghal and consultants will be appointed over the next few weeks
- Cork County Council originally asked for €1.2 million funding for the Mallow Relief Road
- Said €700,000 is needed to get the Mallow Relief Road to planning; €300,000 has been allocated
- It is disappointing to see that the funding for drainage is down
- Said the planning for Cobh Road is at a very early stage
- Said carparks fall under the remit of Municipal Districts and need to be funded by our own resources
- It will be very difficult to progress the Glengariff project
- Said there is no timeline on the climate action and resilience works for Main Street in Carrigaline
- Said it is disappointing that the Bantry Relief Road cannot progress further this year
- Said the maintenance of active travel projects is a concern for the sector and substantial funding is required longterm to progress these

EXTENSION OF HELP TO BUY SCHEME

Cllr. Bernard Moynihan proposed, seconded by Cllr. Gobnait Moynihan

"That the Help to Buy Scheme be extended to people who are bringing derelict properties back into use through the Croi Conaithe Scheme."

Members noted the response from Patricia Liddy, Director of Services, Municipal District Operations & Rural Development as follows:

RESPONSE:

Cork County Council administers the Croí Cónaithe Vacant Property Refurbishment Grant Scheme on behalf of the Department of Housing, Local Government and Heritage. To date, Cork County Council is handling 670 applications for this scheme.

The terms and conditions of the Croí Cónaithe Vacant Property Refurbishment Grant Scheme are determined by the Department of Housing, Local Government and Heritage and in summary allow for grant aid, subject to eligibility criteria being met, for the refurbishment of vacant properties that were built before 2008.

Separately, the Help to Buy Scheme is administered by Revenue on behalf of the Department of Finance and applies to newly built properties.

During this discussion, the Members made the following points:

- Said the fastest way to bring properties back into use is to turn derelict properties into housing
- Said the purpose of this motion is for applicants who are developing houses for themselves to live in
- Members said Cork County Council is the most successful county for the scheme
- A lot of extra resources are needed for regenerating properties in towns, e.g. health and safety measures to take pedestrians into account
- Said the scheme is a quick way of getting money to applicants
- Members said most of the services are already available with derelict properties and can fast track housing
- It would be useful for the Croí Conaithe scheme to be incorporated into the Help to Buy scheme
- The cheapest and greenest house to build is a house that is already built
- Said this is about parity for first time buyers for those who are renovating properties
- Said every town in the county is under the blight of dereliction

Members agreed to write to the Minister for Housing, Local Government and Heritage, and the Minister for Finance to ask that the Help to Buy Scheme be extended to include applicants who are bringing derelict properties back into use through the Croi Conaithe Scheme.

LIFT THE BAN ON PLANNING PERMISSIONS & NEW WASTEWATER CONNECTIONS

Cllr. Declan Hurley proposed, seconded by Cllr. Karen Coakley

"I call on Cork County Council to lift the current ban on new planning permissions and new wastewater connections to allow development in rural county towns and villages where existing treatment plants have available treatment capacity."

Members noted the response from Padraig Barrett, Director of Services, Planning & Development as follows:

RESPONSE:

The preparation of the Cork County Development Plan 2022-2028 included a detailed analysis of the water services infrastructure of the towns and villages across the County in terms of capacity but also having regard to Strategic Environmental Assessment and Habitats Directive Assessment requirements under the Planning Acts. The Plan also has to comply with a range of other EU and National Legislation (Water Framework Directive, River Basin Management Plans Policy Objective WM11-1) in relation to protecting and improving water quality and reversing biodiversity loss. The preparation of the Plan also had to take account of particular water sensitive catchments such as Cork Harbour, Blackwater River Catchment, Bandon River, and Glenbeg Lough/Glanmore Bog SAC.

These considerations within the existing legislative framework required careful teasing out in order to set the parameters for the policies and objectives set out in the CDP in particular within Volume One, Chapter 11 Water Management but also the settlement specific objectives set out in Volumes Three Noth Cork, Volume Four South Cork and Volume Five West Cork of the Plan. Table 11.3: of the Plan entitled," Capacity of Current Water Services Infrastructure to accommodate planned Population Growth 2020-2028, " identifies the settlements where there is a strategic infrastructure deficit.

This position is constantly being updated as new infrastructure is delivered and deficits addressed. Where a strategic infrastructure deficit was identified an objective restricting development until the deficit was addressed was included. If such objectives were not included, then the County Development Plan in its entirety would have been subject to full Appropriate Assessment which would have had significant implications for the Plan delivery across the County. More importantly it could have had implications for the manner in which infrastructure is delivered in terms of specifying how an upgrade had to be undertaken. This is no longer a function of the local authority and could have adversely impacted on the scheduling, cost, and timing of delivery of such infrastructure.

All applications for planning permission are assessed in accordance with the policies and objectives of the CDP, relevant Departmental Section 28 Guidelines and the proper planning and sustainable development of the Area.

The Council continue to work with the various stakeholders in particular Úisce Eireann (ÚE) both by advocating for additional resources through ÚE Investment Plans and through raising settlement specific issues around the County.

During this discussion, the Members made the following points:

- Said this matter was discussed previously with the formation of the County Development Plan
- There will be an upcoming review of the County Development Plan
- Members said they are frustrated with communication from Uisce Éireann
- Development in West Cork is stagnant and at a standstill from this issue
- Said the Freshwater Pearl is stopping development in the Beara Peninsula
- Said it must be acknowledged that the Freshwater Pearl is part of our natural heritage
- Said Dunmanway is also sterilized for development
- Members said they raised the issue previously at an Uisce Éireann conference and no progress has been made since then
- Said Uisce Éireann need to be provided with funds to allow treatment plants to be in place

The Chief Executive stated it is factually incorrect to say there is a ban on planning permissions. Ms. O'Sullivan said it is accepted that the presence / absence of wastewater treatment could be an obstacle to planning permissions. She said the matters raised under this notice of motion are matters for Uisce Éireann to address.

Members agreed to write to the Department of Housing, Local Government and Heritage to make a special fund available to deal with these issues. Members also agreed to write to Uisce Éireann to ask that assessments be carried out before projects are done.

EXTRA EXAMINATION TIME FOR STUDENTS WITH DYSLEXIA

9/4-1

Cllr. Liam Quaide proposed, seconded by Cllr. Úna McCarthy

"That Cork Co. Council would write to the Minister for Education to request that she bring Ireland into line with countries such as France, Italy and the UK in allowing extra examination time to second level students with dyslexia, and thereby afford them more opportunity to attain to their potential."

During this discussion, the Members made the following points:

- Dyslexia affects 10% of the population, mainly impacting on writing and reading skills
- Said people with dyslexia show strengths in other areas but typically achieve lower in education
- Said Ireland should be brought in line with International best practice
- Members said 1 in 10 students have dyslexia and these students need more time for their examinations
- It takes more time for students to transcribe their answer rather than write an answer
- Said it is very difficult to get a reader for students and it is often left to the discretion of the school
- Members said students should automatically get access to a reader once diagnosed with dyslexia
- Said it is also very difficult to access a scribe for pupils with dyslexia
- Said there needs to be more emphasis on audio visual learning

Members agreed to write to the Minister for Education to ask that Ireland be brought into line with other countries such as France, Italy and the UK in allowing extra examination time to second level students with dyslexia.

HOUSEHOLD WASTE COLLECTION SUBSIDY SCHEME

10/4-1

Cllr. Deirdre O'Brien proposed, seconded by Cllr. Eoghan Kenny

"That this Council would consider implementing a Household Waste Collection Subsidy Scheme (Bin Waiver) for persons living alone and in receipt of State Pension."

Members noted the response from Louis Duffy, Director of Services, Environment, Emergency Services, Climate Change and Rural Broadband, as follows:

RESPONSE:

Cork County Council has an obligation under the Waste Management Acts "to collect, or arrange for the collection of, household waste within its functional area".

Household Waste collection services are provided by the private sector in Cork. While not all premises are served at the adjoining kerbside, Cork County Council is satisfied that the estimated costs of the collection of waste in any unserved areas by the local authority would be unreasonably high. Cork County Council has therefor satisfied its statutory duty in regard to the collection of household waste.

The collection of waste is being carried out by private waste collectors in the county in competition with each other and, thus the price for the services is determined by that competition.

The Waste Management Act 1996 as amended, provides that "In accordance with the polluter-pays principle, the costs of waste management, including for the necessary infrastructure and its operation, shall be borne by the original waste producer or by the current or previous waste holders."

Having regard to the foregoing, the Council has no obligation or authority to subsidise the collection of waste from any person. Such action by the Council would contravene the Waste Management Act.

During this discussion, the Members made the following points:

- Said this motion was put forward to assist a vulnerable cohort of people who live alone and are in receipt of the state pension
- These people face a bill of €300 plus annually and do not have anyone living with them to share the cost
- Said it is not good value for money considering a person living alone generates a minimal volume of waste
- Members said low income households can avail of a waiver on waste charges made by private operators in some local authority areas
- Said a one size solution does not fit all here
- Incentives that are used for schools and public areas should be considered for this vulnerable group
- Said it would reduce the issue of fly tipping in public bins and in the countryside

Former Cork County Councillor and TD for Cork East, Joe Sherlock RIP, spearheaded the retention and upgrading of MGH and his son Seán, current Cork East TD and former Cork County Councillor has advocated strongly over the past two decades for MGH, culminating in the building of this wing, securing the future of MGH."

Members agreed to refer this matter to the Social Inclusion, Community and Rural Development SPC for further discussion.

MAYOR'S CHARITY GALA

The Deputy Mayor reminded Members that the annual Mayor's Charity Gala will take place on April 19th.

125TH ANNIVERSARY OF CORK COUNTY COUNCIL

The Deputy Mayor advised Members that a special meeting of Council will take place on April 22nd to mark the establishment of Cork County Council. Following the meeting, an event will be hosted in the Foyer of County Hall from 12.30 pm.

INSHORE FISHERMEN

Members said the Government need to intervene in the current situation that is impacting inshore fishermen. Smaller boats are affected more by the weather than the larger boats. Members said these fishermen have had no income for 5 months and need urgent help.

Members agreed to write to the Department of Agriculture, Food and the Marine to ask that financial aid is urgently given to inshore fishermen.

FARMING COMMUNITY

Members said current adverse weather conditions are causing economic strain on the farming community. Members agreed to write to the Minister for Agriculture and the Cork TD's on this matter.

SUSPENSION OF STANDING ORDERS

TERMINATION OF PAY SCHEME FOR HEALTHCARE WORKERS WITH LONG COVID
