### 2. LECP Update on Draft Framework Plan & Draft Initial Implementation Plan

Sharon O'Connell presented an update of the LECP Draft Framework Plan and Draft Initial Implementation Plan to the members of the Local Community Development Committee and identified amendments following consultation with the Southern Regional Assembly and the 8 Municipal Districts. It was proposed by Arran O'Driscoll Murphy and seconded by Phoebe Bright.

The Chair paid tribute to Sharon O'Connell for the huge amount of work in bringing the plan to where it is today. He thanked Sharon and looks forward to the launch in April.

## 3. Presentation on Census 2022 Data for Cork County – Justin Gleeson, People & Place

Justin Gleeson from People & Places Consultants gave a very comprehensive presentation on the 2022 Census data to the West Cork Local Community Development Committee with particular focus on the West Cork division.

 The Chair thanked Justin and commented on the large volume of data included in his presentation. He noted that it didn't appear to include towns in the West, Bantry, Dunmanway, etc.

Justin confirmed that there were 12-13 towns across West Cork included.

Phoebe Bright commended the visuals, they were all very clear. Regarding the Ageing Population section, while the current ageing population is included, what about a more active aging population, '50 the new 40s' etc. The demand for services will be different and don't appear to be included. Sharon O'Connell responded that one of the key objectives of the draft framework plan is to focus on people being active throughout their lives, and to continue to be active and healthy in the community.

 Ryan Howard acknowledged the huge importance of this information. There is a lot of success in the County. With the City being a strong driver, there is an imbalance too.

He highlighted the need for action in the future with regards to DEIS schools, a challenge that needs to be brought forward.

Ryan stressed the importance of using this data. As an LCDC, he queried what was going to be done with this information, what is West Cork's focus in terms of jobs, places to live, sustainability and queried if we need to think in terms of services, what we want for our community, progressive forward planning is required.

Justin Gleeson acknowledged the positives in West Cork and the opportunities.

- The Chair commented that he feared there is over centralisation, that this can stifle taking advantage of opportunities. Important how we use this information to progress.
- Cornelius Buckley commented on the incredible amount of data. With regards to fishing and agriculture, if we were to take that out of West Cork, we'd have nothing.

Cornelius Buckley added that West Cork's mostly disadvantaged, there is a lot of farming and not everyone can survive. There is massive production and need to keep hold of this.

Justin Gleeson agreed, at least 20-30% in the agricultural area.

- Cllr. Patrick Gerard Murphy highlighted the need for infrastructure and sited an
  example of one individual who had won a Southern Star Business Award but was
  unable to get housing. There are jobs in the Beara Peninsula, the coastline is big
  for tourism and activities and that there are wins if the necessary resources are
  available.
- Kevin Curran agreed on the importance of fishing and agriculture, and the significant value to the raw materials produced, cheese, yoghurt, etc. These all lead on to further jobs. He added that West Cork is not homogenous, take the coastal belt and the inland areas, a lot of internal differences within the county.

Justin Gleeson commented that there is higher disadvantage in the inland areas.

 Phoebe Bright added to the acknowledgement of the importance of agriculture and highlighted the difference in the value of the family farm versus large scale farming.  The Chair commented that economics is the driving force there, as well as the availability of other work.

The Chair once again acknowledged the large volume of information presented and stressed again the importance of using this data.

### 4. Healthy Ireland Fund Update - Niall O'Callaghan, Healthy Ireland Co-Ordinator

Niall O'Callaghan, Healthy Ireland Co-Ordinator, provided the West Cork Local Community Development Committee with an update on Healthy Ireland Round 4 Fund. This presentation included the key outcomes of round 4 Healthy Ireland Fund.

He highlighted that he had close engagement with the LECP Advisory Group and that he worked with many groups in West Cork, as well as the Local Development Companies.

The Chair thanked Niall for the informative presentation.

Arran O'Driscoll asked who is the Lets Play Coordinator. Niall O'Callaghan responded that following a recruitment process, Martin O'Donoghue was appointed.

### 5. LCDC Annual Report 2023

The Chief Officer presented the 2023 West Cork LCDC Annual Report for approval in compliance with the LCDC Guidelines. She informed the committee that once approved, it will go to Full Council in March.

The West Cork Local Community Development Annual Report for 2023 was proposed by Kevin Curran and seconded by Eileen O'Shea.
