#### Welcome and Introduction

It was noted that a quorum was in place and the meeting commenced.

 Confirmation of Minutes of the Previous LCDC Meeting of Monday 18<sup>th</sup> December 2023

The Minutes were adopted on the proposal of Cllr. Gerard Murphy and seconded by Sean Hegarty.

### 2. LECP Update on Draft Framework Plan & Draft Initial Implementation Plan

Sharon O'Connell presented an update of the LECP Draft Framework Plan and Draft Initial Implementation Plan to the members of the Local Community Development Committee and identified amendments following consultation with the Southern Regional Assembly and the 8 Municipal Districts. It was proposed by Cllr. Gearóid Murphy and seconded by Cllr Gerard Murphy.

- Cllr. Pat Hayes thanked Sharon O'Connell and her team for their amazing work and time with putting this together and note that it is important and critical for both now and the future and that the formulation and engagement with this was positive.
- Cllr Gearóid Murphy echoed the words of Cllr. Pat Hayes, thanked Sharon and the LECP team for their work in consulting with stakeholders, the LCDC's, Economic & Enterprise SPC's and LECP Advisory Group.
   Cllr Gearoid Murphy queried if the LECP Advisory Group will be continuing to meet up during the implementation stage.
  - Sharon O'Connell responded that the Advisory Group will continue to meet as this is the key principle for successful implementation.
- Cllr. Gerard Murphy acknowledged the work of Sharon and her team and noted that
  the information contained in the LECP will be used by everyone to identify needs of
  every area of the county especially in the disadvantaged areas. He highlighted that
  even though the County is doing well in some areas there are particular areas of
  disadvantage which he hopes won't be forgotten when it comes to funding.
- Nuala Glanton noted that the Socio-Economic element of the LECP was very useful and queried why the Education Training Board wasn't mentioned when other



education providers were mentioned as the ETB would have similar high level goals as those education providers and actions would overlap.

Sharon O' Connell responded by stating that Cork County could have had 3 LECPs due to the various challenges & issues throughout the county and People & Places have extensive data to support this however, the High level goals are broad enough to support all areas and Stakeholders when making funding applications. She added that the Implementation Plan is a live document so can be amended as things change and she would welcome any additional feedback from the CETB however, it was clarified that the CETB are represented on the Advisory Committee so would have had the opportunity to feed into the current plans.

# 3. Presentation on Census 2022 Data for Cork County – Justin Gleeson, People & Place

Justin Gleeson from People & Places Consultants gave a very comprehensive presentation on the 2022 Census data to the North Cork Local Community Development Committee with particular focus on the North Cork division.

- Cllr Pat Hayes thanked Justin for his comprehensive and interesting
  presentation that had incredible facts and figures which will be shared with
  all LCDC members.
- Cllr. Gerard Murphy mentioned that Kanturk and Mallow are two very different electoral areas however, as they are combined as an electoral area the facts are not showing the true makeup of both areas.
- Cllr. Gearóid Murphy supported Cllr. Gerard Murphy's statement and added he was concerned that Buttervant being the smallest town is seen as the only disadvantaged town in the North Cork area.
  - Justin responded this by saying that there is additional extensive data available when you drill down further but unfortunately the LECP can only show so much information in order to get discussions started.
- Cllr. Pat Hayes mentioned that Mallow used to be the hub for food production but has lost these industries resulting in less focus on the town centre
- Sean Hegarty noted that villages need to buy into this whole process as well as many skills have been lost.



The Chief Officer thanked Justin for his presentation.

# 4. Healthy Ireland Fund Update - Niall O'Callaghan, Healthy Ireland Co-Ordinator

Niall O'Callaghan, Healthy Ireland Co-Ordinator provided the North Cork Local Community Development Committee with an update on Healthy Ireland Round 4 Fund. This presentation included the key outcomes of round 4 Healthy Ireland Fund which were Breastfeeding Support and Positive Mental Health Projects. Niall O'Callaghan mentioned he worked along with many partners such as Muintir na Tire, HSE, UCC, chambers in Mallow and Midleton to make these key outcomes possible.

Niall O'Callaghan highlighted that he had close engagement with the LECP Advisory Group.

- Cllr. Pat Hayes thanked Niall O'Callaghan for his detailed report and update.
- Cllr. Gearóid Murphy mentioned that it is good to see the emphasis on mental health programmes and work being done.
- Nuala Glanton had a query about the date for the youth event in Mallow. Niall responded that no date has been finalised yet and that he will notify the LCDC members when a date is available.
