Members noted the response from Nicola Radley, Director of Services, Corporate Services:

## **RESPONSE:**

The National electoral registration process changed in October 2022 making it easier for individuals to register to vote and update their own personal details when *Check the Register*, an online platform, was introduced.

Since then, the Franchise Section has registered 34,149 voters, amended details (added date of birth, PPSN's, and updated addresses) of 30,794 voters and deleted a further 12,800 voters (deceased, moved to another local authority area or duplications).

It should be noted that the register is now a Rolling-register and, as such, is being continuously updated by Franchise Staff and by members of the public who choose to update their own personal details.

The updating and verification of the data on the Register is of utmost priority to Cork County Council, and as a measure of the importance of the register, we bolstered the Franchise Team by 12 additional members of staff across an 8 week period in the run up to the Local Elections when extensive work on updating the register was undertaken.

This targeted approach was in addition to multiple other measures and various communication campaigns encouraging members of the public to both register for the first time and to log onto the system to check their details. These measures have included:

• All schools and nursing homes were contacted in 2023, and were contacted again before the Referendum and before the Local Election in 2024 to encourage voters to register and/or check their details.

- The Franchise team attended the Summer Show in 2023 and were available on the day to help voters to register and update their details.
- A bilingual radio campaign was run in October 2023 for 2 weeks on local radio stations
- Bilingual advertisements were placed in local and regional newspapers (The Corkman, Southern Star, Cork Independant, Youghal & Midleton News, Lee Valley Outlook and Muskerry News) and on all Cork County Council online platforms in November 2023, with a recurring online message being shared prior to the Local Election.
- In an additional and targeted approach, in November and December 2023, 13,602 voters in the Macroom LEA and 11,222 voters in the Fermoy LEA were written to and asked to contact the Franchise team either by phone, letter or online to provide their date of birth, ppsn (optional) and Eircode so their details could be updated on the Register.

In the period post local-election to date, the following have been submitted to the Franchise Section for processing:

- 250 amendment forms (with an average of 10 amendments per form) received from the polling stations.
- 7660 applications (including 1,694 new registrations and 5,966 updates) on Check the Register
- Presently 400 paper forms to be processed.

The updating of these entries on the Register are currently being prioritised by the Franchise Section.

Members made the following points:

- Full acknowledgement of the body of work carried out by the Franchise team.
- Education programme for schools and non nationals is needed.
- The onus is on the individual to check if their details are correct.
- Polling cards were slow to be issued.
- The new system needs to be discussed at a national level.
- We have to ensure that people are not taken off the register.
- There is still a huge volume of work to be carried out post election.

Chief Executive, Moira Murrell and Director of Service, Nicola Radley responded as follows:

- There have been significant improvements made to the register.
- We have requested updates be made to the system.
- Any deletions are done with a reasoning and there is back up to support this.
- There is a huge degree of personal responsibility in notifying the franchise section.
- GDPR is first and foremost.
