4. NOTICES OF MOTION/ FOGRA RUN

(a) CIIr. Finbarr Harrington

"That this Council would carry out much needed line paining as a matter of urgency and Safety at Gour on the R572 Castletownbere to Allihies main road". This is the main R572 road along the Wild Atlantic Way and is a noted location for thick fog especially in Winter time. Currently there are no road markings on this road. That this stretch of road especially at the top of Gour would be considered for cats eyes or road study retro reflective safety devices".

"That this Council would give an update as to when the renovation of the public toilets in Allihies Village will commence. Allihies public toilets were granted €50,000 in March 2019 at Municipal district and work has not commenced yet".

"That this Council will secure a public toilet for Sherkin Island before Summer 2025."

(e) Clir. Isobel Towse

"In relation to the €200,000 THRIVE funding for Kent St, and other potential funding options for this street, that this council will share any plans or ideas that the council has for its redevelopment, will explain what the process is for constituents to have their say in this development, and when this will be available to them."

(f) Cllr. Deirdre Kelly

"In line with successful measures in Killarney and Dungarvan that this Municipal District would consider and pilot the use of dog waste bins in West Cork".
