# 3. BREITHNIÚCHÁIN AR THUAIRISCÍ AGUS MOLTAÍ CONSIDERATION OF REPORTS AND RECOMMENDATIONS

## (a) Municipal District Officer's Report

Members noted the Report as detailed.

- 2025 Village Enhancement Scheme (VES)
   In response to Cllr. G. Moynihan query on Coachford's allocation under VES, M.
   O'Leary, MDO confirmed that when the current works in the village are completed, this funding will be utilised.
- Cllr. E. Lynch proposed spending a portion of the VES funding towards installing ramps. J. Dwyer, SEE said that ramps would not be suitable for many locations. He said it is a long process as firstly there would need to be a design carried out and followed by a Section 38.

Cllr. Moynihan & Cllr. Looney both concurred with Cllr. Lynch's proposal and requested that the idea is revisited again in future.

## (b) Rylane Speed Survey Results

J. Dwyer, SEE said as per the results, the speed through the village was high, 86% of traffic exceeded the speed limit of 50 km/h, with a reported 85th percentile speed of 83 km/h. He said that Cork County Council has a Policy in place for the assessment and installation of Traffic Calming measures. Ramps are only one of the options and are usually the least favoured option to be considered. He said advice needs to be sought as to how progress this and that funding would also need to be found. Cllr. Creed requested that these results are shared with An Garda Síochána.

Cllr. Lynch said this was a very disappointing result, she said in the absence of a ramp what other options are available. Cllr. Moynihan said she was not surprised at the results and said that safety measures needed to be initiated as soon as possible.

In response, J. Dwyer, SEE said there are several options that can be considered. He said that the Roads Design Office have the expertise and he would wait to see what they recommend.

M. Murphy, SEO agreed that the results should be forwarded to An Garda Síochána and said it was important to open up a dialogue with them.

# 6. CHUN NA RUIN SEO LEANAS ÓN GCOMHAIRLEOIR A MHEAS: To consider the following Notice of Motions in the names of:

#### Cllr. Eileen Lynch

"That Macroom MD would provide extra parking in Lyon's Terrace, Coachford and in Fr Sheehan Place Coachford. That clarity would be provided as to which section of Cork County Council is responsible for these kind of works and what funding is available for same."

#### Response

The Housing Department is not in a position to fund the provision of additional parking in Council Housing Estates. The limited funding available for estate management is stretched to meet existing demand and cannot extend to the provision of parking spaces.

Maurice Manning Director of Services, Housing

Cllr. Lynch expressed her disappointment at the lack of funding and queried if there was any funding stream available at Municipal District level. Cllr. Creed & Cllr. Lucey both agreed saying parking was a huge issue and needs to be addressed. T. Donovan, MD Manger said it would be investigated.

Cllr. E. Lynch & Cllr. M. Looney both excused themselves from the meeting.

#### Cllr. Ted Lucey

It has been brought to my attention about the volume of traffic and speed on the Millstreet Road from the slip road off the ByPass to the Millstreet Cross. While the slip road onto the ByPass is of huge significance for commuters coming and going into the town it has created a large volume of traffic on this road.

This area is after getting very built up with a lot of new housing developments, there is approximately over 400 houses according to the Registers of Electors in this area. On average 2.5 people live in each house, that's 1,000 people. Approximately 2 cars to each house, that's 800 cars coming and going from the area several times a day. This isn't taking into consideration the amount of traffic that is commuting from Macroom Town and surrounding areas to get onto the ByPass and also traffic commuting into the town and surrounding areas coming off the ByPass.

I have seen first hand myself the speed on this stretch of road is after getting extremely fast and residents trying to get out onto this road are finding it extremely dangerous and are very concerned that a serious accident will occur. Even pedestrians crossing the road are finding it very frustrating. I feel that this stretch of road should have got more attention during the development of the ByPass.

I very much welcome the pedestrian crossing at the Inver Garage but I am asking that some sort of traffic calming solution be looked into to reduce the speed in the area as there is a lot of young children living in these estates.

### <u>Response</u>

This section of the R582 lies within the 50km/h speed limit. Traffic patterns have changed in this area since the opening of the N22 Macroom ByPass. In 2024 CCC did install a pedestrian crossing opposite the Inver Petrol Station both to cater for pedestrian usage and to act as a traffic calming measure however this is still awaiting ESB connection so it is too early yet to judge its effectiveness. We can investigate the possibility of providing additional traffic calming measures

further north along the road. Initially I would like to carry out traffic counts and speed surveys which will determine the next steps in this process.

I also think it would be worthwhile for this MD to write to AGS expressing concerns about speed in this area and request that speed enforcement action be taken.

Cllr. Lucey requested that An Garda Síochána are contacted about this issue. He also queried if a traffic calming plan could be included as part of the Active Travel Scheme. Cllr. Creed concurred with this suggestion. J. Dwyer, SEE said he will arrange to carry out a Traffic Survey and said he will be in contact with TII regarding the Active Travel Scheme. Cllr. Moynihan said progress is being made and was pleased that a pedestrian crossing was installed and commended all involved. She said it was important not to forget pedestrians, they need to be included also.

#### Cllr. Gobnait Moynihan

#### Response

TII are currently working on this section of the old N22 replacing the road surface and widening the public footpath. My understanding is that this contract includes constructing a new footpath east of Kellihers Garage and the petrol station however this element of the works is still in design.

The MD will raise the matter with TII and revert with their response.

James Dwyer Senior Executive Engineer

J. Dwyer, SEE said that TII have confirmed that there is no funding available for the provision of a footpath from Kellehers Garage to Coolcower Roundabout. A discussion took place where the Members expressed their dissatisfaction. Cllr. Coughlan queried the funding received for the works at Coolcower Picnic Area and asked where the footpath will be going as part of this project. J. Dwyer, SEE outlined that no drawings or costings have been finalised for this project as yet. An update on that project will issue in the near future.

## 9. AON GHNÓ EILE ANY OTHER BUSINESS

## **Councillor Ted Lucey**

(a) Road Resurfacing Through Macroom Town — Road Closed at Night
Cllr. Lucey said it is important to stress even though the road will be closed at night
during the works in the town, diversions will be in place and Macroom Town will be open
for business as usual, local traffic will continue to have access at all times. Cllr. Moynihan
said it should also be stressed that Macroom Town is open for business by day and by
night.

(b) New Wastewater Pipe in Macroom Town

Cllr. Lucey said that the Members had a meeting last November with Uisce Éireann and he raised the issue of the new wastewater pipe that was planned for Macroom town and it was agreed that the pipe works should be carried out at the same time as the resurfacing works. At that meeting Uisce Éireann said they would write to TII to agree

a plan. Cllr. Lucey said that Uisce Éireann have not yet made contact with TII and asked if Kevin Morey, Divisional Manager or equivalent to write to Uisce Éireann for an update. T. Donovan, MD Manager confirmed that said she will follow this up.

## **Councillor Gobnait Moynihan**

- (a) <u>Pedestrian Crossing, Millstreet Road, Macroom Lights Not Working</u>
  J. Dwyer, SEE said the ESB plan to carry out works on the lights shortly.
- (b) <u>"Boil Water" Notice, Macroom</u>

  Cllr. Moynihan commented that people are buying large amounts of bottled water and feels that Uisce Éireann should be in a position to offer some type of compensation.
- (c) Millstreet Gym Update
  M. O'Leary, MDO confirmed that this project has gone to tender, with tender evaluation currently underway and it is hoped that the successful tenderer will be in place shortly with works commencing. She hopes to have an update for the February MD Meeting.

## **Councillor Martin Coughlan**

- (a) <u>St. Colman's Park, Macroom Lack of Parking Spaces</u>
  Cllr. Coughlan cautioned at the lack of parking spaces in St Colman's Park with some cars parking illegally and is fearful of a potential accident or emergency services being unable to access the area. He asked if a survey of the area could be undertaken between Cork County Council and An Garda Síochána to look at available options.
  - M. Murphy, SEO cautioned that any potential future investment in parking will be required to fund itself. He feels that dialogue between the Council and AGS is something that will be useful to all.
- (b) Entrance to Macroom Hospital
  Cllr. Coughlan said the entrance is very unsightly and wondered if there was any funding available from planning development charges. Cllr. Lucey agreed saying it should be prioritised. This matter will be further investigated.
- (c) Car Park Signs in Macroom Town
  Cllr. Coughlan asked about a maintenance plan for maintaining key public items in town,
  (i.e. signage, bollards, poles etc) and asked for additional signage to indicate car parking
  in the town. M. Murphy, SEO confirmed that a plan is being put in place which will make
  provision for these items and T. O'Donovan, MD Manager outlined that there will also be
  Community Wardens assigned who will work locally with the engineers.
- (d) <u>St. Gobnait's Tce, Ballyvourney Pool of Water</u> J. Dwyer, SEE to investigate this matter.
- (e) <u>Coolcower Picnic Area Funding secured by Tidy Towns for project</u>
  Cllr. Coughlan referenced the recent funding granted to Macroom Tidy Towns under the 2024 Community Recognition Fund for a project at Coolcower Picnic Area and footpath to Coolcower House. Final drawing and costings currently being done for this project.
- (f) New Road Sweeper, Macroom

  Cllr. Coughlan expressed his satisfaction with the new sweeper, he said it has made a dramatic improvement to the appearance of the town already.
