

ORDÚ LUASTEORANN OIBREACHA BÓTHAIR/ ROADWORKS SPEED LIMIT ORDER

**Section 10 of the Road Traffic Act 2004, as amended by Section 55 of the
Road Traffic and Roads Act 2023.**

Notice is hereby given, pursuant to Section 10 (1) of the Road Traffic Act 2004, as amended, BY Section 55 of the Roads Traffic & Roads Act 2023, that a Road Works Speed Limit Order has been made in the interests of road safety and to facilitate the installation of ducting and joint bay chambers associated with the Celtic Interconnector Project along the N25 between Killeagh and Youghal, Co.Cork.

Location:

(N25) – introduce a 60 KPH speed limit on N25 between Killeagh and Youghal Town i.e. to the bypass and the N25 Slip Road to the R634.

The proposed reduction will start at the existing speed limit signs to the east of Killeagh (co-ordinates 200919, 76581) and extend to the eastern end of Youghal Bypass (co-ordinates 206904, 76433) and the eastern end of the N25 Slip Road to R634 at Youghal (co-ordinates 207166, 76388).

Existing Speed Limits through Killeagh and Youghal will remain unaffected.

The Road Works Speed Limit to be applied shall be 60km/h (reduced from 100 km/h)

This speed limit applies from midnight on Thursday 13th March 2025 to midnight on Friday 18th July 2025 or such earlier date as determined by Cork County Council.

Relevant speed limit signs will be in place.

Tugtar fógra leis seo, de bhun Alt 10 (1) d’Acht na mBóithre 2004, arna leasú, LE hAlt 55 den Acht um Thrácht ar Bhóithre agus na Bóithre 2023, go ndearnadh Ordú Luasteorann Oibreacha Bóthair ar mhaithle le sábháilteacht ar bhóithre agus chun suiteáil duchtála agus cuasán bá siúntála a bhaineann leis an Tionscadal Idirnascaire Ceilteach feadh an N25 idir Cill Ia agus Eochaill, Contae Chorcaí.

Suíomh:

(N25)– luasteorainn 60 KPH a thabhairt isteach ar an N25 idir Cill Ia agus Baile Eochaille i.e. chomh fada leis an seachbhóthar agus Sliosbhóthar an N25 leis an R634. Tosóidh an laghdú molta ag na comharthaí luasteorann atá ann cheana ar an taobh thoir de Chill Ia (comhordanáidí 200919, 76581) agus leathnóidh siad chomh fada leis an deireadh thoir de Sheachbhóthar na hEochaille (comhordanáidí 206904, 76433) agus an deireadh thoir de Shliosbhóthar an N25 leis an R634 ag Eochaill (comhordanáidí 207166, 76388).

Ní bheidh tionchar ar na Luasteorainneacha atá ann cheana féin trí Chill Ia agus Eochaill.

Is é 60km/h an Luasteorainn Oibreacha Bóthair atá le cur i bhfeidhm (arna laghdú ó 100 km/h)

Beidh an luasteorainn seo i bhfeidhm idir meánoíche Déardaoin, an 13 Márta 2025 agus meánoíche Dé hAoine, an 18 Iúil 2025 nó cibé dáta is luaithe ná sin de réir mar a chinnfidh Comhairle Contae Chorcaí.

Beidh na comharthaí luasteorann ábhartha ann.
