Regular Inspections of Animal Breeding Facilities: Implement a schedule of unannounced inspections for all licensed animal breeding establishments to ensure compliance with animal welfare standards.

Public Awareness Campaigns: Launch educational initiatives to inform the public about responsible pet ownership, the importance of reporting animal cruelty, and the legal repercussions of neglect and abuse.

By adopting these measures, Cork County Council will demonstrate its commitment to upholding and advancing animal welfare standards, ensuring that such incidents are significantly reduced in the future."
