**Cllr Donovan**

1. To request information in relation to burial grounds across the Carrigaline MD:
  - (i) How many plots are available to purchase in the MD and a breakdown of where they are located?
  - (ii) What forward planning is Cork County Council taking in relation to the purchase of land to either extend current cemeteries or build new ones?

2. To request that this MD would install traffic calming measures along Strand Road, Monkstown.
3. To request that the MD would seek funding to resurface the overflow car park at the rear of the Owenabue Carpark and install lined parking spaces.

#### **Cllr Buckley**

1. To ask the Carrigaline MD Office Engineer for an update on the current Church Bay Road works and to request access to the detailed drawings of the project. I am also aware that, after nearly 30 years of building in Crosshaven, the contractor will soon be leaving the area. With this in mind, I am seeking confirmation that the raised table at the pedestrian crossing near Drake's Point will be reinstated and that a safe connection to the footpath is ensured for school children and pedestrians.
2. Can we please look at relining and reinstating the two designated wheelchair parking spaces at the Fountainstown front parking area, which were previously removed? These accessible spaces are essential to ensure inclusive access to the beach and surrounding amenities, especially for those with mobility challenges. Their absence has been noted by several users and local advocates.
3. Can I ask how much of our revenue budget is currently allocated to seasonal litter bins in the Carrigaline MD area? Additionally, could I be provided with the percentage of the overall summer season budget that was spent on seasonal bins in 2024 at our local beaches in the Carrigaline MD area?

#### **Cllr McCarthy**

1. That this Council actively explore and pursue suitable land opportunities for the development of a multi-use games area and a pitch and putt course within the town, in order to enhance recreational amenities for residents of all ages.
2. That this Council install a second speed ramp on Riverview Terrace, Passage West to further reduce vehicular speed and improve road safety for local residents.
3. This council considers the implementation of traffic calming measures on R613 Ballea Road, Carrigaline to enhance safety for all road users. Additionally, that the speed identifier sign be relocated further away from the roundabout to provide drivers with more time to adjust their speed appropriately.

### **Cllr Fahy**

1. That this Municipal District would make a collective submission on the Luas calling for the inclusion of Carrigaline and the surrounding areas.
2. This MD would write to Cork City Council to request that they carry out permanent repairs on the three persistent issues on the R610 Rochestown Road.
3. That Cork County Council will review the road leading to The Meadows, Parkview and both schools in Passage West, as there is a sinkhole appearing along with the road cracking.

### **Cllr Dalton O'Sullivan**

1. Residents of the Mountain Road, Carrigaline (especially towards the Coolsallagh side) have requested that where possible, the sides of the road could be cleared as when one car meets another, it is often quite difficult to back their cars. By clearing the sides of the road, it would allow an extra bit of room to manoeuvre.
2. Requesting that School Road, Ballygarvan and Meadstown Hill be included in a list of areas for the line marking contractor to mark 'SLOW' on the road. Noting the proximity of the school to both locations and the concerns raised by parents.
