MAY 2025 - NOTICES OF MOTIONS

Cllr. Frank O' Flynn

1. "that Cork County Council resurface and line the public car park by the church and school in Shanballymore".

Cllr. Nelius Cotter

2. "that Cork County Council would consider traffic calming measures (ramp or raised table) on Ballindangan Road from Ard na Gréine, Mandeville Park and Ailesbury Court".

Cllr. Kay Dawson

3. "call on Cork County Council to get a response from ESB or the contractors for the reason it is taking so long to repair street lighting in Castlelyons:

Kent Terrace Pole 61 Job 157271 / Deerpark Pole 31 Job 148847 / Main Street Pole 20 Job 55311".

4. "that this Council would give consideration, under future Restoration Improvement (RI) programmes, to the resurfacing of the L-5775-11 and L-5775-0 roads in Glannagoul, Kildinan, given their current condition and local usage".
