

CORK COUNTY COUNCIL
ROADS ACT, 1993
TEMPORARY CLOSING OF PUBLIC ROADS

Pursuant to Section 75 of the Roads Act 1993, & Article 12 of the Roads Regulations 1994, notice is hereby given that Cork County Council proposes to temporarily close the following roads for the period and reason specified below:-

Roads Subject of Proposed Closure

1. L-32340-0 Short Quay, Kinsale
2. L-9719-0 Market Street, Kinsale
3. L-9720-0 Main Street, Kinsale
4. L-97200 Crowley's Quay, Kinsale

Period of Proposed Closure

1. Short Quay L-32340

From 08:00hrs on Monday 3rd May 2021 to 18:00hrs on Thursday 30th September, 2021 (Daily Closure).

2. L-9720-0 Main Street (including L-9719-0 Market St.) from L-9721-0 Upper O'Connell St. (& Market Square) to Crowley's Quay.

From 08:00hrs to 18:00hrs on **Sundays only** starting on Sunday 9th May 2021 until Sunday 26th September 2021 (inclusive) (Daily Closure).

Reason for Proposed Closure

To facilitate the **temporary pedestrianisation of streets during the summer season to assist both with National Social Distancing Guidelines and the re-opening of businesses**. The overall objective is to create Pedestrian Priority Zones within the Town Centre thereby promoting a Covid Safe Environment on our public streets that is mutually beneficial to both the Town's people, visitors and businesses.

Alternative Routes

Closure (1) Short Quay:- proceed via R-600 Emmet Place turning onto R-605-98 Pearce St. turning left onto L-3234-0 Market St. at the White House.

Closure (2) Main St. & Market St.:- proceed via L-3234 Market Sq. turning onto R-605-98 Pearce St. at the White House. Follow R600 south bound to Crowley's Quay or Denis Quay (diversion route operates in reverse) L-9721-0 Upper O'Connell St. remains open from Guardwell to Denis Quay but is unsuitable for large vans, HGVs etc.

Local access will be maintained throughout the duration of the Road Closures for deliveries (07:00hrs to 10:00hrs) and those with special needs.

On Market St. local access will be maintained as far as "Joe Neville's Yard".
